Children Incorporated provides resources to children in need in the United States and abroad because we passionately believe that children everywhere deserve education, hope and opportunity.

We believe in helping children all over the world who face adversity in their daily lives which may keep them from ever attending school and receiving an education.

We believe that in order to understand the individual needs of children, it is essential to have partners in the community who can focus on those needs because every child is different, and their circumstances vary.

OUR WORK

We are a top-rated international nonprofit organization that supports children and families who face challenges due to poverty. Through our partnership with 225 affiliated sites around the world, we provide basic needs to children so they can attend school, receive an education and have the opportunity to succeed.

OUR HISTORY

In 1964, after personally witnessing the deprivation of children in Guatemala, our founder, Jeanne Clarke Wood, established Children Incorporated out of her home in Richmond, Virginia by writing letters to seek assistance for the 95 children she met on her travels. The support her friends and family provided for these children formed the first Children Incorporated site. After subsequent trips abroad, the program began to flourish and expand, and today, Children Incorporated has programs in the United States, Asia, Africa and Latin America.

OUR AREAS OF IMPACT

EDUCATION

We provide children with educational resources throughout the year such as school supplies, bookbags, and tablets for virtual learning. We also purchase desks and school uniforms and pay tuition so children living in poverty have everything they need to attend school ready to learn.

EMERGENCY RELIEF

There are many instances when families living in poverty are not financially prepared for emergency situations, such as with sudden illness or a house fire. Our Hope In Action Fund ensures that when unexpected needs arise, we can help families immediately.

HEALTH AND WELL-BEING

One of our highest priorities is making sure children are healthy so they don't miss school. We provide children around the world with proper shoes and clothes, hygiene items, healthy food on a regular basis, as well as vitamins as needed.

COMMUNITY SUPPORT

We believe strongly in supporting children, families and communities to help people break the cycle of poverty in which they live. We support construction projects, playground and greenhouse projects, renovation projects and skills training projects at our affiliated sites in order to uplift multiple groups or people at a time.

HOW WE WORK

Children Incorporated partners with already-established schools, group homes, and community centers to address the specific needs of the children they serve, offering each child basic needs every month. Our volunteer coordinators at each of our affiliated sites also inform us about the greater needs of each child's families, the sites where they work, and the local community so we can offer lasting support that creates real change on a global scale.

WAYS WE HELP

1. CHILD SPONSORSHIP

Sponsorship provides a child with basic and education-related necessities such as food, clothing, hygiene items, and school supplies. Our policy is to consider the needs of each sponsored child on an individual basis. Our volunteer coordinators personally shop for the children enrolled in our program and choose items based on each child's personal circumstances and needs.

2. SPECIAL FUNDS

Donations to our Special Funds help children, families and communities in need by offering support beyond sponsorship, often due to unexpected emergencies.

3. SPECIAL PROJECTS

Our Special Projects allow our donors to support construction projects, expansion projects, community and school gardens, and other efforts to help improve our affiliated sites around the world.

OUR IMPACT IN THE UNITED STATES: NAVAJO NATION

Our volunteer coordinator, Crystal, at the Dzilh Community School in New Mexico, writes about the impact that Children Incorporated donors have on students at her school:

“The funds that the Children Incorporated program provides have had a huge benefit for our students who are in high need of this support. When we coordinate our shopping trips with the parents, they are very pleased with the outcomes, and so much joy is brought to the students. It brightens their day to take home newly purchased items such as food, clothes, school supplies, books, and hygiene items. Many of our students come from disadvantaged homes where they are cared for by a grandparent, single parent or other family member. Thanks to the Children Incorporated Hope In Action Fund, when we moved into a new facility, we received a \$15,000 grant to purchase new books for the library. Overall, Children Incorporated sponsors and donors have made a huge impact on the students’ needs. It has brought so many smiles and words of ‘thank you’ from our students. We could not successfully support so many of these children without your help.”

OUR IMPACT IN THE UNITED STATES: APPALACHIA

Karen at South Floyd Elementary School in Kentucky writes to us to express her gratitude for everything that our sponsors and donors are able to do for children in need in her community.

“COVID-19 caused many changes in our school, and just as we were on the cusp of recovering from it, a devastating flood hit Eastern Kentucky. Many students lost every single thing they owned. Children Incorporated Hope In Action Funds allowed me to restock families with clothing and hygiene items — things they really needed while they worked toward recovery. Beyond that, sponsors’ generosity is a blessing. It is the reason I am able to buy Christmas gifts and birthday gifts for children. My Children Incorporated sponsored children are not used to receiving such gifts. Watching their eyes light up when they receive a gift is something I never tire of seeing.”

“I want to thank you for all that you have done and are doing for the children at our school. I’ve always said it takes a village to help children, but I also believe that it takes just one person with a caring heart.”



OUR IMPACT IN THE UNITED STATES: INNER CITY

Kimberly at Swansboro Elementary School in Richmond, Virginia writes to us about her experience as a volunteer coordinator with Children Incorporated.

“Children Incorporated has been so vital to the success of my students. People don’t often think about how little things can affect a student’s learning experience, but the little things add up. It took some time for my sponsored children to understand where the funding was coming from, because they really couldn’t believe that a stranger would help them, but when I explain the program, they all think it is amazing.”

“I try to emphasize to the students that it is important for them to know it is OK to receive help, and it’s always good to help when we can. These students get so excited when I tell them we are going on a shopping trip, and not just because they get to help pick out groceries or new clothing for themselves — it’s also because they know that someone is helping them.”

OUR IMPACT: PUERTO RICO

Puerto Rico is our newest affiliation in the United States Division, and our work there helping children and families in need is only possible thanks to our amazing sponsors and donors. Our President and CEO, Ron Carter, writes about how our work in Puerto Rico is profoundly changing lives.

“After many years of planning, we were able to establish our first site on the island called Iglesia Bautista de Metrópolis. Iglesia Bautista de Metrópolis is located in Carolina, and the church was created from an older congregation called Bautista Cristo Restaura, which is located in Levittown. Our sponsorship program currently serves children who live in the areas surrounding both Iglesia Bautista de Metrópolis and Bautista Cristo Restaura, but is operated under just one name.”

“As we continue to grow our program in Puerto Rico, we find that the needs of children and families are many and diverse. In addition to the constant need for food, clothing, and hygiene items, Iglesia Bautista wants to establish before-and-after-school care for children in the vicinity of the church, to provide these precious children with a safe space and to keep them off of the dangerous streets. They are also looking to update the bathrooms in their center, construct a stormproof storage area where supplies can be kept dry, and to provide child-size work tables and benches where the children can do their homework and create crafts. Sports and audiovisual equipment are always in demand, and a big dream is for a van to transport the children and their families to and from the center and within their community. Our donors’ and sponsors’ support has allowed us to help fund these efforts to expand and grow, and we are proud to be a part of it.”

OUR INTERNATIONAL IMPACT: ASIA

Our Director of Development, Shelley Callahan, discusses our efforts in the Philippines, after having a chance to visit our affiliated sites in the country in early 2023.

“When I first started at Children Incorporated in May of 2014, I remember hearing a lot about our relief efforts in the Philippines after Typhoon Haiyan, which had devastated areas of southeast Asia in November 2013. I clearly recall stories from our staff about the damage that had occurred in Tacloban, where our affiliated site, the Visayans Center (which is run by nonprofit organization, Volunteer for the Visayans, or VFV) was located. After the storm passed, it would be recorded as the country’s worst-ever natural disaster. According to our volunteer coordinator at VFV, WimWim, although a lot of help was needed after the typhoon, in many ways aid organizations didn’t offer the sustainable support that she felt was vital to those living in poverty in Tacloban. Often times, said WimWim, aid organizations didn’t consult with locals about how to offer help in the ways that it was needed most — instead, administrators would determine how they felt they should help, which sometimes wasn’t helpful at all.”

“Children Incorporated, she said, has never been one of those types of organizations. Having worked with VFV since 2005, and still expanding on the work we do together today, we have offered VFV consistent and continuous support through very hard times in the community. WimWim proudly spoke to me of the power of sponsorship, and how grateful she was for the flexibility of our program that allows her to decide exactly what children need — whether during a disaster or in times of relative calm.”



OUR INTERNATIONAL IMPACT: AFRICA

Our volunteer coordinator, James, at the Dandora Center in Nairobi, Kenya, writes to us to express his gratitude for Hope In Action Funds that have allowed him to improve and expand the school, which is all to the great benefit of the children we serve there.

“Dear Children Incorporated,

Receive warm greetings from us all at the Dandora Center, and we hope that this finds you well! The children are fine and getting on well with their daily school activities in this rather short but very busy term. Soon national examinations and assessments will be setting in, and afterwards the children will be entering the long December holidays. At this juncture, I look back and appreciate with gratitude how much we have been able to achieve at the center through your support, which has made the environment for the children so conducive to learning. I am glad that the boys’ restroom that I mentioned to you during my last communication is now complete and only needs to be painted. We have now begun constructing the girls’ restroom hoping that it will be complete by the beginning of next year. Upon completion of these restroom blocks, we hope to renovate the current room being used as toilets and convert it to a more spacious computer room that will be able to accommodate all the children with ease.”

“I appreciate the support you gave us to construct the first floor of the new classroom block which is currently being used by the children in the junior secondary school. We hope that next year we can manage to do the final floor and roofing of the block to prepare for ninth grade classrooms. Your love for the children at the center gives us hope that we can achieve anything!”

OUR INTERNATIONAL IMPACT: CENTRAL AMERICA

Our Director of International Programs, Luis Bourdet, writes about his visit to our affiliated site, Santa Julia, in Mexico, where our sponsors help keep siblings together through difficult times.

“At Santa Julia, each girl that is enrolled at the home is there because social services in Mexico has deemed their home life to be unfit — and in fact, once the children are enrolled at the home, they are there until they are 18 years old and can determine for themselves as adults if they want to have contact with their families again. When they are removed from their homes, the situation is often so horrific that the parents don’t know where their children are being taken for the children’s protection.”

“During their time at the home, the girls take swimming lessons and create art to show off at a local restaurant. They also participate in a Christmas Bazaar where they sell small crafts that they made by hand. The goal of the Santa Julia home is to teach the girls to learn good habits and values, especially respect for one another, to achieve consistency with their education, and to achieve comprehensive development through physical activity and proper nutrition. Beyond all this, the girls also receive medical services, dental services, psychological services and ophthalmological services throughout the year. Additionally, Santa Julia managed to expand its programs in the last few years and began including brothers of the young girls during their intake process. Over the years, the staff of Santa Julia noticed that they had several cases in which girls who were separated from their home were not only having a difficult time adjusting, but were distressed over no longer being with their siblings and feeling alone and abandoned. Additionally, the support these children receive from their sponsors is invaluable to their growth, development and overall well-being.”

OUR INTERNATIONAL IMPACT: SOUTH AMERICA

In Colombia, our work with the Rondon Center not only ensures that children living in extreme poverty are receiving the support they need, but mothers are also learning skills and gaining employment so they can be more fully independent in their own lives.

Located in Bogotá, the capital of Colombia, the Rondon Center offers basic needs to impoverished children in the community, largely thanks to the funds they receive from Children Incorporated sponsors and donors, while also operating “Creaciones Miquelina,” a garment-making factory that trains women while paying them a living wage so they don’t have to take on jobs in the city that could be potentially dangerous for them and their children.

OUR SPECIAL PROJECTS



At the Montero School in Santa Cruz, Bolivia, our donors have supported the building of an agricultural school that supports higher education and skills training for students. Shelley Callahan, our Director of Development, writes about her visit to the school in March 2023.

“When we turned off the dusty main road to enter the school’s property, all I could see was open land – land that the Montero School administrators had purchased to use for the agricultural school years back with the promise that Children Incorporated would provide funds for the classrooms, greenhouses, stables, barns and silos. We parked in front of the entrance to the school, and walked onto the property, which was expansive. Buildings lined the right side and the fields for farming were on the left, probably covering the distance of two football fields.”

“Our volunteer coordinator, Sister Reina, explained that students who attend the school are enrolled in a five-year program – some start while they are still in high school at the Montero School, and some start after graduation. They grow corn, fruit and other local produce, while raising pigs and chickens, and learning how to compost and operate and maintain heavy machinery.”

“As we walked the grounds and chatted about the school, visiting the new classrooms and getting to see the progress that has been made with working so much land, I could see why Luis was so enthusiastic for me to see the school for myself. With few opportunities for families living in poverty in Bolivia to send their children on to higher education to learn a trade, it was apparent that this school was an absolute blessing for so many students, who would gain the skills they need to generate an income for themselves, and provide a better future for their own kids someday.”

HOPE IN ACTION FUND

Contributions to our Hope In Action Fund support children and families in emergency situations, like when natural disasters strike and in times of extreme hardship due to health challenges. Hope In Action funds are also used to help families that are unable to pay for school activities for their children and to help our volunteer coordinators provide additional resources to children in our program as needed.

SHARED HOPE FUND

We enroll new children in our program every day, and finding enough sponsors for all of them is one of our greatest challenges. The global need is so profound that some children wait months for a sponsor. Donations made to our Shared Hope Fund provide immediate assistance to children awaiting sponsorship.

FEEDING PROGRAMS FUND

Donations to our Feeding Programs Fund provide children with food to take home on the weekends when they otherwise might not receive regular meals in their household, as well as provide daily meals to children in schools when meals are not provided for free. Thanks to this important fund, children eat well and can attend school alert and ready to learn.

CLOTHING FUND

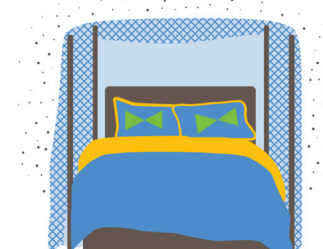
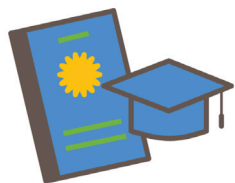
Donations to our Clothing Fund purchase boots, coats, hats, scarves, and gloves for our sponsored children living in regions with particularly harsh winter weather, and provide shoes and clothes during emergency and non-emergency situations. Ensuring that children have proper clothes and shoes to wear to school keeps them healthy and is essential to their well-being.

BACK TO SCHOOL FUND

Back to school is one of the toughest times for children in need. Not having new outfits or school supplies to start the school year off right can diminish a child's confidence and make it difficult for them to focus. Contributions to our Back to School Fund make it possible to give children a positive start so that they feel confident while in school.

MOSQUITO NET FUND

Children around the world need mosquito nets to protect them from mosquito-borne illnesses like malaria and dengue, so that they'll be healthy enough to attend school. Each year, we purchase thousands of nets that we distribute to children and their families, thanks to donations to our Mosquito Net Fund.



YOUR CONTRIBUTIONS AT WORK

Each and every year, we are able to provide more than 20,000 children worldwide with basic needs thanks to our sponsors and donors. Not only is our reach far and wide, but because we focus on allowing our volunteer coordinators to determine the specific needs of children, their families, and the communities in which they work, we feel confident that your contributions are doing the most good for some of the most vulnerable people in the world, and therefore leaving a lasting impact.

- Provide funds to repair the study room used by students at the La Recoleccion School in Nicaragua



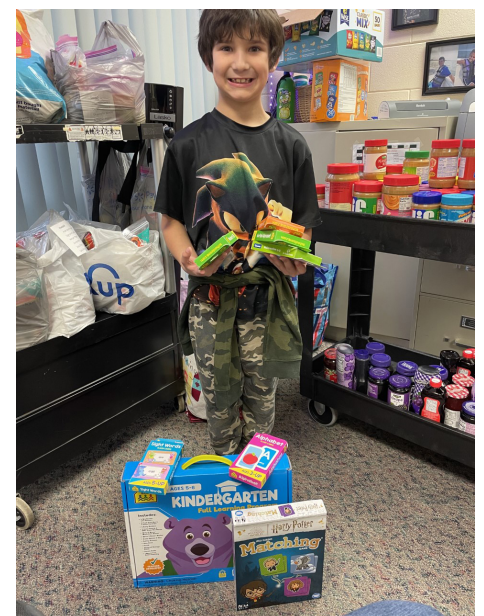

A LETTER FROM OUR PRESIDENT AND CEO

Dear Friends,

I will enter into my 12th year as President and Chief Executive Officer of Children Incorporated in April of 2024. Over the years, people have often asked me what makes our organization stand out from other child sponsorship and child assistance organizations. I often tell them that Children Incorporated is not a cookie-cutter organization. Rather than providing all of the children at a site location with the exact same items, such as a pair of pants or a jacket, we work with our volunteer coordinators — who manage our programs in each school or childcare facility — to meet each child's immediate and individualized needs. One child may need a pair of shoes, while another may need a winter coat. Yet another may be in a family that doesn't have any food in the house. Our volunteer coordinators notice these specific situations and work to address them. They live and work in the areas where the children live and they are acquainted with what is needed in each household. Our coordinators do an incredible job of meeting those needs, one by one.

Another thing that truly sets us apart is how our site locations and programs are run. Our network of volunteer coordinators are not paid by Children Incorporated. They are already, in most cases, employees of the schools or centers where our programs are established, and their positions are such that they actively seek out assistance for the children in their areas who are living in poverty. They agree to manage the Children Incorporated programs in exchange for the benefits the children and their families receive. They see how incredibly valuable what we offer is to the children, families, and communities they serve. This volunteer method has worked quite well for 60 years, and it allows us to send a lot more money directly to children in need. Instead of spending money paying additional salaries, we use the money for goods and services to aid the children we assist, which is invaluable to them.

A third characteristic that sets Children Incorporated apart from other child sponsorship organizations is our wonderful staff. We currently have just 14 paid employees, and they are all devoted to our cause and mission. These folks work quite well together, with each employee at Children Incorporated wearing many different hats, often stepping in to help their co-workers wherever and whenever needed. It is pretty incredible that a staff the size of ours can accomplish so much – overseeing approximately 225 site locations and numerous special funding projects – yet our employees do the work and make the difference each and every day.

Lastly, I must say that our sponsors and donors are the backbone of our outreach. Children Incorporated has some of the most loyal supporters in the world. We have sponsors and donors who have been funding our work for 60 years, some who personally knew and worked with our founder Ms. Jeanne Clarke Wood (1916 - 2006). Our sponsors and donors have provided millions of dollars to children and families over the decades, and their generosity continues today.

Children Incorporated is a special organization, and I consider myself extremely fortunate to be at the helm. Thank you for affording me so many wonderful opportunities.

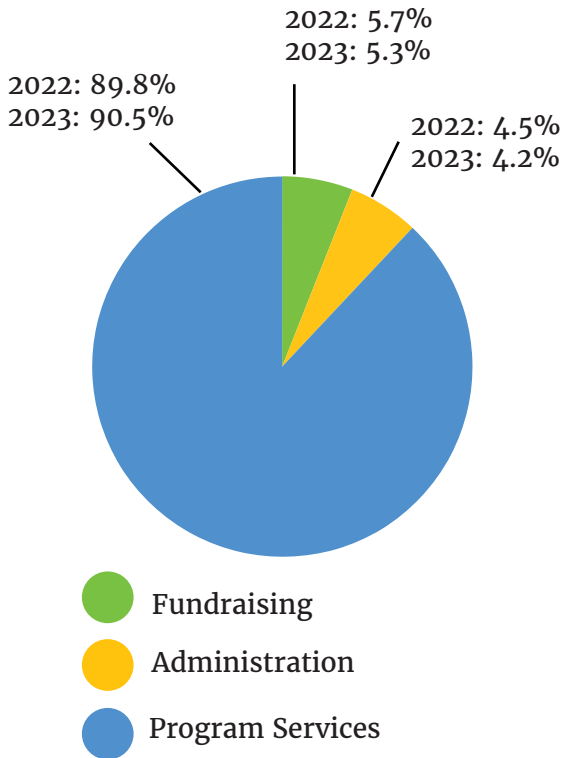
