

Dear Friends,

Children Incorporated is audited annually by the firm of Yount, Hyde, and Barbour CPAs and Consultants (YHB), based in Winchester, Virginia. YHB, which has been in business since 1947, is highly respected among financial institutions. It is recognized by numerous organizations, including the American Institute of Certified Public Accountants, the Virginia Society of Certified Public Accountants, and the Maryland Association of CPAs. Each year in July, YHB sends our bookkeeper and CEO a list of documents that will be needed when their team arrives in our office in September to begin the annual audit.





Our bookkeeper, Anita Holder, spearheads the gathering of this information and works tirelessly to make sure that Children Incorporated has all of the supporting documentation necessary for the audit team when they arrive. YHB is very thorough. As part of their audit work, they sample all aspects of Children Incorporated's accounting processes. Their audit team usually consists of three analysts who spend a week in the Children Incorporated office in September of each year. At the end of that week, the YHB team meets with Ms. Holder and our CEO, Ron Carter, to discuss their findings. They also provide an annual report to our Board of Directors. We post our IRS Form 990s and audited financial statements, both prepared by YHB, on our website in keeping with Children Incorporated's vow of transparency.

Children Incorporated is an honest organization, and we take these annual audits quite seriously. As a direct result of our efforts, we have continuously been ranked high by all of the major charitable monitoring groups.

EDUCATION. HOPE. OPPORTUNITY.

Charity Navigator, perhaps the most revered among these, has rated Children Incorporated 4 out of 4 stars for well over a decade, with an overall score of 98 out of 100 in its most recent findings. We are also highly rated by Charity Watch, the Better Business Bureau Wise Giving Alliance, and GuideStar/Candid.

For over sixty years, Children Incorporated has been serving children and families in need. The organization has always had a policy of visiting each site location at least once every two years. During those visits, our staff does its own audits (in addition to our annual organizational audit by YHB). Each of our affiliated sites is required to submit financial reports to our Programs Division either quarterly or semi-annually, and we definitely pay attention to those reports. We appreciate the generous contributions entrusted to us, and we work to make sure that each dollar is spent correctly and most efficiently. We proudly present our 2024 Annual Report. ABOUT CHILDREN INCORPORATED

Children Incorporated provides basic necessities, such as food, clothing, healthcare, and educational support to children living in poverty in the U.S. and abroad. These essentials, so often taken for granted, are vital to a child's growth and success in school. Each year, we give thousands of children from impoverished households a chance at a better life.

Today, thanks to past and current supporters around the globe, we work with nearly 225 affiliated sites in 20 countries, including the United States, which serve over 20,000 children annually. Children Incorporated partners with already-established schools, orphanages, homes, and childcare centers to address the specific needs of the children they serve. Each of our affiliated sites has its own local staff member, who we refer to as our on-site volunteer coordinator, who administers our programs on a volunteer basis.

These volunteer coordinators work to ensure that every child enrolled in our program is provided with clothing, food, hygiene items, school supplies, and other educational tools regularly through either our sponsorship program or our special funds. Our work spans across the globe from the United States to Central America, to East Asia and the Pacific as well as in South America, South Asia and Sub–Saharan Africa. Currently, we support children living in poverty in seven U.S. states, Washington, D.C., Puerto Rico and in nineteen countries outside of the United States.

OUR HISTORY

In 1964, after personally witnessing the deprivation of children in Guatemala, our founder, Jeanne Clarke Wood, established Children Incorporated out of her home in Richmond, Virginia by writing letters to seek assistance for the 95 children she met on her travels. The support her friends and family provided for these children formed the first Children Incorporated project.
