OUR HISTORY

In 1964, our founder, Jeanne Clarke Wood, witnessed the deprivation of children in Guatemala firsthand. She established Children Incorporated out of her home in Richmond, Virginia by writing letters to help the 95 children she met on her travels.

The support her friends and family provided formed the first Children Incorporated site affiliation. To date, we have provided opportunities, encouragement, and hope to over 500,000 children.

WHAT IS SPONSORSHIP?

The sponsorship relationship enables a sponsor to support a child in need by means of monthly contributions and, if the sponsor so desires, through the exchange of correspondence. Sponsors may write to their children and in turn, children can write back. This is completely voluntary but available to those who wish to participate.

A sponsor's friendship and encouragement is priceless to a child in such circumstances. Indeed, many children value the relationships they establish with their sponsors as much as they value the financial help they receive. Our current monthly sponsorship rate is \$35, and it goes toward providing basic necessities, such as school supplies and fees, food, clothing, and access to healthcare, among other services.

Thank you for believing in their future. Your generosity extends far beyond financial support—it brings dignity, opportunity, and lasting change. Every photo and story we share tells a story of persistence, growth, and potential. Stories made possible because of you.

HOPE IN ACTION

To Provide Hope When Challenges Arise

Sometimes, the challenges children face can't wait. A sudden illness, a family emergency, a natural disaster, or a missing basic need can disrupt a child's ability to learn, grow, and thrive. That's why we created the Hope In Action Fund — to step in quickly when urgent needs arise and provide support where it's needed most.

SHARED HOPE

Waiting For Sponsorship Shouldn't Mean Waiting For Help

Every morning, children in our program wake up hoping for stability — clean clothes, a full backpack, a decent meal. For roughly 500 children, that's a hope that hasn't yet found a sponsor. They're enrolled; they show up. But some essentials are still out of reach.

The Shared Hope Fund exists for moments like these. It fills urgent gaps: when a child's school supply is missing, when no sponsor has stepped forward, when emergency needs press in. Because while sponsorship may come, today's needs cannot wait.

So They Can Walk Into The Classroom With Confidence

Imagine walking into class on the first day without a backpack, with shoes that don't fit, or without a pencil or paper. For children already facing challenges at home, this added stress can make school feel impossible. School can bring more worry than excitement. Without new clothes or basic supplies, they feel unprepared and embarrassed — often too anxious to focus on learning.

By providing essential items like backpacks, notebooks, pencils, shoes, and outfits, you make sure children start the year with dignity and hope.

FEEDING PROGRAM

Because No Child Should Learn On An Empty Stomach

When children don't have enough to eat, it's hard to focus on school, or anything else. Hunger drains energy, blurs concentration, and steals the joy of childhood. Our Feeding Program Fund ensures that children receive nutritious meals every day so they can learn, grow, and thrive.

MOSQUITO NET

Preventing disease one net at a time

In Kenya, Ethiopia, Sri Lanka, and India, children need mosquito nets to protect them from mosquito-borne illnesses such as malaria and dengue, so they'll be healthy enough to attend school.

Each year, Children Incorporated purchases thousands of nets that we distribute to children and their families.

WHAT IS SPONSORSHIP?

Child Sponsorship with Children Incorporated is a personal, one-to-one commitment. You will be paired with a specific child who will directly benefit from your monthly contribution of \$35. This recurring support provides essential needs such as clothing, school supplies, hygiene items, healthcare, and food. Your sponsorship helps meet these basic needs and gives the child hope and a chance for a better future by supporting them physically, emotionally, and socially.

HOW LONG CAN I SPONSOR?

We hope you will assist your sponsored child until he or she leaves our program. This typically occurs when a student graduates from high school or moves away from an affiliated site. Due to the trying circumstances of the regions where they reside, we cannot predict or guarantee how long a child will remain enrolled in our sponsorship program, although we make every effort to provide services to children for as long as possible.

HOW MANY CHILDREN DO YOU SERVE?

We have around 10,000 children enrolled in our sponsorship program at any given time. Since 1964 we have assisted more than 500,000 children! We maintain 225 affiliated sites in eight U.S. states, Puerto Rico, and 19 other countries.

WILL I RECEIVE UPDATES ON THE CHILD I SPONSOR?

You'll receive updates that bring you closer to your child: usually a progress report and a new photo about once a year, sharing highlights of their growth, hobbies, and milestones. The children also write at least one letter each year, offering a special chance to connect with them personally. While timing may vary by location, these moments remind you of the wonderful difference you're making in a child's life.

MAY I WRITE/SEND PACKAGES TO THE CHILD I SPONSOR?

Yes! Corresponding with your sponsored child can be a wonderful experience. Writing about your own family and hobbies is always a good place to start. You will find the site mailing address in your child's information brochure. For children in the U.S., packages of already-purchased items should be mailed directly to your sponsored child's affiliated site's address. Unfortunately due to high customs duties and the likelihood of loss, we do not recommend sending packages to our affiliated sites outside of the U.S. Children Incorporated cannot guarantee receipt of any packages you send internationally.

FREQUENTLY ASKED QUESTIONS



WHAT HAPPENS IF THE CHILD I SPONSOR LEAVES THE PROGRAM?

When a child leaves our program for any reason, we promptly notify you and provide details about another child who needs your support and encouragement just as much. If you feel called to continue your sponsorship journey with a new child, wonderful! If not, just let us know by phone or email—we're here to help.

While we cannot maintain contact with children once they leave the program, please take comfort in knowing that your generosity creates a lasting, positive impact on the life of each child and on their community for years to come.

IS IT POSSIBLE TO VISIT MY SPONSORED CHILD?

It is possible to visit sponsored children; however, since we work with a network of volunteers we cannot guarantee that all sites are open to sponsor visits.

If your sponsored child's site does allow visits, you must contact us at least 45 days prior to your desired visit, so we can make arrangements with the site, parents, and site volunteers. Arranging a visit does also include a background check at the sponsor's expense.

HOW DO YOUR VOLUNTEERS ADMINISTER AID TO AFFILIATED SITES?

Working with volunteers allows us to keep our programs highly efficient. Our coordinators are teachers, social workers, guidance counselors, school principals, or other childcare professionals who interact with the children on a daily basis. They observe firsthand the circumstances of each child's life, and have a "boots on the ground" perspective on what will work best to meet the unique needs of each child.

DOES MY GIFT QUALIFY FOR A TAX DEDUCTION?

Children Incorporated has been a registered 501(c)(3) charitable organization since 1964. Contributions, therefore, may be eligible for tax deductibility status.

We strongly recommend that you consult with your tax advisor when making such determinations.

ADDITIONAL WAYS TO GIVE

LEGACY GIVING

Legacy giving allows you to make a gift to Children Incorporated through estate or financial planning. A legacy gift takes your needs, as well as the needs of your loved ones, into consideration while helping support the mission of Children Incorporated well into the future.
